CAREER PROFILE

Alberto Martini has been actively involved with impact evaluation since the start of his professional career almost 30 years ago. After completing his Ph.D. in Economics at the University of Wisconsin-Madison in 1988, he joined Mathematica Policy Research, then as well as now one of the leading organizations (in the use of randomized controlled trials, and participated in the design and analysis of demonstrations that included random assignment of program participants.

In 1998 he returned to Italy mainly to be an advocate of evidencebased policy, as well as of a rigorous approach to impact evaluation. Undaunted by the total lack of success of his effort in his homeland, he brought his advocacy to Brussels, where, perhaps by sheer coincidence, something clicked. He was asked by DG Regio to rewrite the section on counterfactual impact evaluation of EVALSED, the on-line evaluation guide of DG Regio. In the mean time he kept teaching counterfactual impact evaluation methods in a variety of setting across Europe and has written extensively about it, both in Italian and in English, including two monographs. In the most recent years, he finally managed to do some real impact evaluation with some real funding, from philanthropic foundations as well as from a hitherto unlikely source. the EU. With the team at ASVAPP and a wide number of other partners, he has completed or he has underway 5 (five) random assignment evaluations, on topics ranging from learning chess in primary school to increasing the employment chances of people with severe mental illness
